### 3. Terms of Reference

#### (Lease of Equipment **Baking Technician**)

#### i)Mandate

To provide the equipment on lease located at IIFPT, Bhatinda (Punjab)for the purpose of Skill training of job roles under National *Skills Qualifications Framework (NSQF)* followed assessment and certification under Skill India from Food industry capacity skill initiative (FICSI).

#### ii) Scope

The scope for terms of reference is applicable but not limited to the training providers in nearby area of Bhatinda, Punjab provided that the imparting training probably at Bathinda or within the state of Punjab only.

#### iii) Period of Lease & security amount

The initial term of this lease is three (3) years, which shall be extended later by renewal at the discretion of the competent authority. A security amount shall also be deposited with lease agreement which is fixed Rs 5,00,000 for the equipment in the form of DD in favour of Director, IIFPT, Thanjavur from lessee which is refundable 60 days beyond the expiry of the contract period after satisfactory completion of the lease agreement.

#### iv) Use and the Purpose

The Lessee expressly agrees and warrants that the leased machinery and equipment shall be used exclusively for training and skill development on NSQF job roles and not to be used for any commercial purpose. Training on Skill development of human resource is a priority area for Government. Therefore, lessee is hereby prohibited to use said machinery & equipment for any other purpose without the prior written consent of the IIFPT.

#### v) Request for proposals

IIFPT hereby invites proposals from reputed training providers or expert institutions having adequate experience in trainings and skilling on NSQF job roles.

**vii) Transportation of Plant and Machinery**

The transportation of equipment and machines from training centre of IIFPT, Bhatinda to the location of training partner and return shall be incurred by the lessee. The equipment is available at LO, Bathinda. The interested parties can inspect the same after the prebid meeting but before expiry of bid submitting date. The machineries have to be returned to IIFPT-LO, Bathinda after expiry of initial terms of lease period or in case the lease is renewed at the decision of the CA in working condition and the cost involved towards transportation at the time of the returning the materials should be borne by the lessee. Working condition of the machineries should be ensured by the lessee in the presence of the lessor.

#### **4. Terms and conditions:**

- i. The lease amount shall be made to the IIFPT by lessee on 1<sup>st</sup> January of each year.
- ii. The applicant shall submit a declaration note with the submission of lease agreement stating that the leased machinery and equipment shall be used exclusively for training and skill development on NSQF job roles.
- iii. The training centre shall be affiliated with FICSI or other skill development agencies.
- iv. The training provider shall submit a quarterly report to IIFPT at the last working day of the month in soft copy. The soft copy of the quarterly report will be comprised of the training programs and candidates trained in each month & future trainings and activities to be done in next quarter.
- v. The training provider shall submit a yearly report to IIFPT at the last working day of each year in soft copy. The yearly report shall comprise of all the activities done in every year and outcome of these activities.
- vi. The equipment shall be returned with the same condition as it was at the time of delivery to the lessee by the lessor.
- vii. The successful lessee shall enter into lease agreement covering a period of 3 years after depositing the security amount and minimum lease amount.

3. Pre-Bid for lease of **Baking Technician** will be held on **25.11.2020 by 04.00 PM** at IIFPT, Thanjavur. Interested firms are requested to attend a prebid meeting with the institute technical evaluation committee via skype. 4. The technical bid and the financial bid should be sealed in a separate cover duly superscribed and both these covers are to be put in a single cover which should be sealed and duly superscribed. EMD / relevant exemption certificate may be furnished with the technical bid.
5. Tenderers/bidders are requested to visit the website regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through website.
6. Technical Bids will be opened on **10.12.2020**. Online presentation and Financial Bids will be opened later after finalizing the technical bids.
7. In case, any holiday is declared by the Government on the day of opening, the tender will be opened on the next working day at the same time. IIFPT reserves the right to accept or reject any or all the tenders.
8. The interested firms participating in the tender are required to deposit Rs. 10,000/- (Rupees Ten thousand only) as Earnest Money Deposit (EMD) in the form of crossed Bankers Cheque / Demand Draft / Bank Guarantee from any of the Commercial / National Bank in favour of THE DIRECTOR, IIFPT, Thanjavur payable at Thanjavur. Bidders registered under NSIC for the tender item or having Udhog Adhar Memorandum number or registered as MSE as per MSME Act 2012 are exempted from payment of EMD and they must upload the relevant certificate. Claiming EMD exemption without uploading the certificate will result in rejection of the bid summarily.

LATE, THEN BIDS WILL BE REJECTED SUMMARILY. Further, EMD will be liable to be forfeited if bidder withdraws or amends impairs or derogates from the tender in any respect within the validity periods of the tender.
